DIRECTIONS FOR APPLICATION

DRY APPLICATION for ALFALFA and TRUE CLOVER

- PRE-VAIL should be applied to dry, clean seed.
- PRE-VAIL will stick to dry seed; therefore, do not use water to wet the seed nor use adhesives or stickers.
- Apply inoculant at specified rate.
- Allow PRE-VAIL to thoroughly mix with seed; should appear white.

COATING APPLICATION for ALFALFA and TRUE CLOVER

- PRE-VAIL can be used as a pre-inoculant in seed coating or buildup process.
- It is important to allow the seed coat to be permeable by oxygen.
- Use this product before the expiration date; label seed with the same expiration date if pre-inoculated seed or coated seed is for re-sale.

To achieve maximum coating efficiency of seed being reinoculated, it is recommended the seed be first slowly screened to shake off excess inoculant material.
